

Recently, it has become more obvious that some of the shiny civility shown in professional practice has started to tarnish. The Florida Bar has noticed too. We are now all required to complete an additional CLE Requirement: *Professionalism Expectations: A Mandatory CLE for Members of The Florida Bar.* Here is a link to the free course: Florida Bar New CLE Requirement

In addition to the course requirement, the Supreme Court of Florida adopted revised Professionalism Expectations.

Part of the Court's Corrected Opinion emphasizes "Florida's professionalism standards apply to all forms of communication, including online communication, and to both in-person and remote (video or audio) interactions with others". See <u>Supreme Court of Florida SC2023-0884</u>. It never hurts to take a minute (or more) and consider a response to an email before replying in a manner that is lacking in professionalism and serves little purpose.

Family law practice, in particular, requires the management of clients and their emotions on a heightened scale. While it is easy to mirror the outrage of our clients, rarely is the client's best interest served by parroting back what they want to hear. Often this bolstering of client emotion leads to ratcheting up the tensions and turmoil of the case, which inevitably trickles down to the children.

I believe that our local family law bar is overwhelmingly congenial and most of us consider each other friends as well as colleagues. We see each other in court, by Zoom, and often at weddings, holiday celebrations, and major personal life events. Battles are being fought in our personal lives and on behalf of our clients.

SEEKING VOLUNTEERS FOR IRAQ-AFGHANISTAN MEMORIAL

Dunlawton Avenue, Port Orange

We are excited to announce that "A Grateful Nation Cares, Inc." (AGNC), a Florida non-profit (pending), which three local volunteers are in the process of forming is planning to erect an Iraq Afghanistan Memorial to the Fallen and the Families of the Fallen. The project has been initiated by Eric Gill, Diana Johns, and Jake Johansson. Dedicated not just to those lost in combat; equally important we recognize losses extend beyond the war zone, including veteran suicides. In 2018, one study found nearly 20 veterans per day die by suicide. Since Sept 11, 2001, the total lost to post-combat suicide is over 30,000 which is several multiples of those lost during time of war. Cause and result are the same.

THE MESSAGE: "It's not enough a grateful nation remembers. More so, a grateful nation cares." Honoring those lost in service to our country, their families and all whose lives they touched. Their Memorial Day is 24/7 for the rest of their lives

MEMORIAL CONCEPTUAL PLAN: Looking like they are coming home from deployment, life size bronze castings of soldiers will be the center piece of the monument. Our central figure draws inspiration from Air Force Sgt Tara Brown fallen in Afghanistan in 2011, our central figure is smilling and flashing thumbs-up, happy to be home. The second statue draws inspiration from two fallen service members: Daytona's Anthony Davis fallen in Iraq, 2009, and Sgt Tulsa Tuliau, late of New York, fallen in Iraq 2005.



Air Force Master Sgt. Tara R. Brown, 33 of Deltona, FL assigned to Air Force Office of Special Investigations, Joint Base Andrews, MD

Died April 27, 2011 serving during Operation Enduring Freedom in Kabul, Afghanistan of wounds sustained from gunfire from an Afghan military trainee.



Army Staff Sgt. Anthony D. Davis, 29 of Daytona Beach, FL, assigned to the 1st Battalion, 75th Ranger Regiment, Hunter Army Airfield, Georgia.

Died January 6, 2009 serving during Operation Iraqi Freedom in Tikrit, Iraq, of wounds sustained when he was shot by enemy forces.



Army Master Sgt. Tulsa T. Tuliau, 33 of Watertown, NY, assigned to the 3rd Battalion, 314th Field Artillery Regiment, 2nd Brigade, 78th Division, Fort Drum NY.

Died September 26, 2005 serving during Operation Iraqi Freedom, in Baghdad of injuries sustained when an IED detonated near his Humvee during combat operations near Rustimayah, Iraq.


