

#### **"CLEAR THE LIST"** Toy Drive



RE: Interest Rate on Judgments or Decrees Effective January 1, 2025

Section 55.03(1), Florida Statutes, requires the Chief Financial Officer of the State of Florida to set the interest rate payable on judgments or decrees quarterly.

Please be advised that the interest rate for the quarter beginning January 1, 2025, has been reduced to 9.38% per annum or .000256284 per day.

Pursuant to section 215.422(13), Florida Statutes, the interest rate for payments to health care providers remains at 1% per month.

Conveniently located on the east coast of Florida between Daytona Beach and New Smyrna Beach, the City of Port Orange is a vibrant, up-andcoming community and home to 66,000 residents. Covering 29 square miles, Port Orange is a moderately sized city in Volusia County with waterfront property lining the intracoastal waterway. Port Orange is accessible via I-95 and US-1. The City operates under a Council-Manager form of government.

Under the general direction of the City Attorney, the Assistant City Attorney provides comprehensive support to department heads on routine matters to protect the interests of the City. The Assis-



tant City Attorney will also assist the City Attorney on complex research tasks and occasional civil litigation.

Port Orange seeks candidates who have the ability to work well with the City Attorney's legal team and can earn the trust and respect of the City's management team. A Juris Doctor Degree from an accredited law school preferably with three years or more of experience as a practicing attorney and a substantial amount of which has been in the practice of local government law, or other relevant experience in the government or private sector. The selected candidate must be an attorney eligible to practice law in Florida with an active Florida Bar license and in good standing with the Florida Bar at the time of appointment.

The City of Port Orange offers a competitive starting salary range of \$96,000 - \$115,000 depending upon qualifications and experience. A generous benefits program including health, dental, and life insurance, paid vacation, sick leave, and other professional development assistance is included. The City offers a defined contribution retirement plan 401(a) with a 10% City contribution, and an optional matching program (457 plan) which allows employees to earn up to an additional 3% contribution on a 2-1 match. The Assistant City Attorney position also qualifies for the Public Service Loan Forgiveness (PSLF) Program. Normal office hours are expected (with occasional after-hours meetings), but there is no residency requirement for the position.


