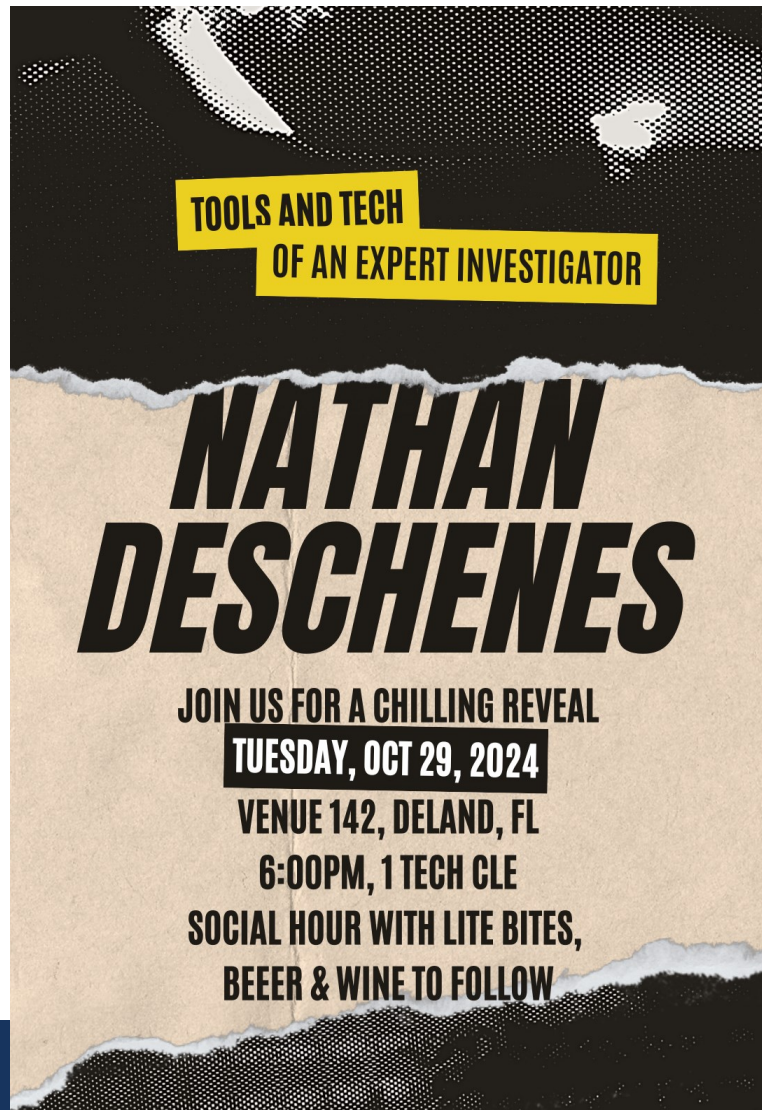

BOWLING FOR BACKPACKS [RECAP]

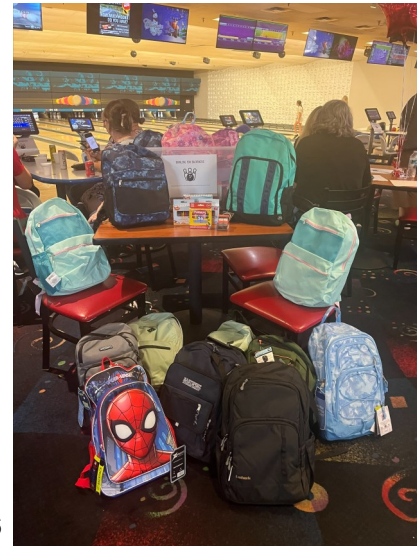

Hello all,

On August 2, I was surprised and honored, but mainly humbled, upon receiving the Pro Bono award from Community Legal Services. I was pleased to accept this, not so much for me, but for the many of us who give of our time and advice to those in need. (With apologies, long-standing plans with family prevented my attendance).

Thank you for this honor. And, thank you to the many staff members who make this happen.

For longer than I can believe, I have practiced law, previously throughout Central Florida, and for the past 10 or so years, primarily here in Volusia County. I've come to know many of you and have enjoyed the collegial atmosphere we still have here, in a legal world filled with so many challenges.

About a year ago, as I began to wind down my practice, I began volunteering at Volusia County Legal Services, at their office on North Nova. My job is to assist clients who simply cannot afford reasonable attorney's fees, but who need legal help; I do this by giving them advice, and reviewing their forms before they file their pleadings and go to Court, on their own. My area of interest and concentration has long been family law, and these are the cases referred to me.

I certainly have had my share of all manner of cases, complicated, custody, high dollar, valuation cases, cases involving forensics, medical, psychology and psychiatry. Much of it has been difficult, and I believe, helpful to the client. And, once in a while, their checks clear.

But this is different: I see people, primarily from lower socioeconomic circumstances, who really need help: they are faced with daunting forms, court rules, different judges, their fear of the uncertainty, to say nothing of the pushback from the "other side". I have helped clients who were sightless, could not hear, or were disabled, those whose first language is not English. I have explained to them that the judge in their case is not there to make their lives difficult, but to accomplish things that need to be done, and done fairly, for them. Each of them, every man and woman, has been most gracious and appreciative for the help I tried to give them.

I take pride in what I'm doing. I realize fully the need for us as professionals to give of ourselves to help those who simply cannot afford to come up with a retainer, and pay the ongoing expenses related to having a court case.

Helping in this way has brought me an appreciation of how fortunate we are to be in the profession we enjoy. My weekly stint does not take a lot of time. Honestly, it is truly rewarding. The satisfaction from a genuine smile, a real thank you, knowing you have helped someone, simply because you can, are intangibles we can all have.

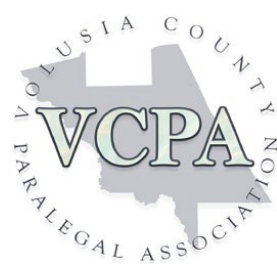
There are many people out there who need our help. This small addition to my activities is no great burden.
